

# **NET ZERO CARBON QUICK WINS GRANTS**

The Church of England Environment Programme has recently provided funding to The Diocese of St Edmundsbury and Ipswich to support churches and church halls in delivering small scale Net Zero Carbon (NZC) works.

The Quick Wins fund can supply funding for up to 90% of your project's costs, to a maximum of £5,000. The diocese will be administering the fund, and our aim is to make the application process simple and to ensure grants can be awarded quickly. The funding programme will run until the end of 2025 or until all funding has been allocated. This means that projects that are awarded funding must be completed by 31st December 2025.

Your application must be submitted using the online application form. This form has been designed to be as simple as possible while also providing the diocese with sufficient information to make an informed decision on grant awards. The link to the application form has been provided below:

# Who's can apply and how much funding is available?

Applications are welcomed from any Church of England church or church hall in the diocese wishing to carry out works to reduce the carbon emissions of their building(s). Grants of up to  $\pounds$ 5,000 are available to cover both the carbon reducing measures and other items, such as height access equipment, that will enable the works to take place.

**Works to the building itself** | Including repairs to roof and rainwater goods, insulating heating pipes, installing loft insulation.

**Heating and lighting** | Replacement of existing lighting (internal and external) with LEDs, installing a smart heating controller such as a HIVE or NEST, acquiring and using data loggers to understand heating and cooling of the building.

**Temporary heating solutions |** Heated chair cushions and boiler hire.

**Electrical upgrades – to enable electric heating to be installed |** Upgrade of electrical supply to increase capacity.

**Other |** Solar PV projects will be considered; however, the building should have carried out all other reasonable actions to reduce its energy use and ideally have replaced fossil fuel heating (if present) with non-fossil fuel heating

# Eligibility criteria, application assessment and further information

# **Eligible buildings**

- Churches and church halls where activities are taking place in a building owned by part of the CofE.
- The church must have completed and submitted the Energy Footprint Tool (EFT) in 2025. Your church may still apply for a Quic Wins grant if you haven't had a chance to complete the EFT yet, however a condition for payment of the grant will be to complete the EFT.

# Ineligible buildings

• CofE congregations meeting in rented or leased accommodation owned by others.

# Cross-funding of projects with other Building for Mission or Net Zero Carbon grant streams

- Cross-funding of projects which meet the requirements of both the Building for Mission Minor Repairs and Improvements Fund and Quick Wins Fund is eligible.
- A church which has previously received a grant from the NZC Programme (for example a Give To Go Green match-funding grant) is eligible to subsequently receive a Quick Wins grant for a separate NZC project, where this project was

not previously funded, or for NZC works which are the next step in a larger project to support the transition to net zero carbon.

#### How will applications be assessed?

Applications will be assessed based upon the carbon emission reductions a project will achieve and/or the amount of energy they could save, the project's readiness level and likelihood of completion by the project deadline (31st December 2025), and the suitability of the project. In the event of the grant being oversubscribed then other criteria may be considered, such as whether the church is a registered "Eco Church" and the deprivation rank of the Parish.

Projects should demonstrate that they will achieve reductions in carbon emissions, such as through energy efficiency improvements or by either replacing or enabling the future replacement of fossil fuel heating systems. If your proposed project is on the list of eligible projects, then it should achieve this objective.

#### Permissions required for works

Please note that all relevant permissions (e.g. list B, faculty) must be sought prior to commencing or carrying out any works – you cannot instruct any contractor to proceed until you have the necessary consents, and the award of a grant from this scheme does not prejudice the faculty application process or otherwise influence the faculty process. The DAC should be consulted to confirm what permissions may be required for any proposed works. If a full faculty is required for works you should ensure that ample time is allowed for the process, considering the schedule of DAC meetings and notice periods.

# Grant funding awards

Up to 90% of the project cost can be funded by a grant, provided the sum does not exceed £5,000. VAT on work is also eligible to receive grant funding, however if the proposed works qualify for the Listed Place of Worship (LPW) scheme for the reclamation of VAT then this element will be excluded from any grant awarded. Half of any grant awarded will be paid on approval of the grant, with the balance being paid after the completion of works and submission of relevant supportive documentation such as a contractor's invoice or Certificate of Completion.

#### When to apply and what happens next

Applications are welcomed from 3<sup>rd</sup> February 2025. Please read the application form and these guidance notes carefully, complete the application form in full and provide

all requested information. Incomplete submissions cannot be considered so please ask for help before submitting if you are unsure about anything.

Your completed application together with any supporting documentation must be received in full by Tuesday 8<sup>th</sup> April at the very latest. All applications will be reviewed by the grants panel during the week starting 14<sup>th</sup> April and you will be informed of the outcome soon after this date.

Further application rounds will be advertised after the round three deadline on 8<sup>th</sup> April if there is funding still available.
