## **Raising awareness of safeguarding - Promoting a Safer Church**

### **Noticeboards and websites**

As summer approaches and we may have more visitors to our churches we would like to remind everyone of the importance of having up to date safeguarding information on display in every church across the diocese. We would ask that checks are made to ensure that your church has a Safeguarding Poster displaying the correct contact details and that safeguarding information features on your websites. We would also encourage you to display the posters and QR codes for the Safe Space project which can be found on our website <u>here</u>.

If you are new to the role, here is a list of the information that you need to include on your website home page.

- 1. A link to www.cofesuffolk.org/concerns-and-contacts
- 2. The name and contact details of your Parish/Benefice Safeguarding Officer
- 3. A formal statement saying that your PCC has adopted the House of Bishops' 'Promoting a Safer Church; and your safeguarding policy statement
- 4. A link to a copy of your policy which should be signed on behalf of the PCC

5. Information about where to get help with child and adult safeguarding issues (these are contained on the Promoting a Safer Church Poster and on the Diocesan website).

Children at risk this summer

Children's charity, Barnardo's has warned that more children are at risk of exploitation during the summer as families struggle to afford activities during the school holidays and children spend more time without adult supervision whilst online or out in the community.

Exclusive online polling of 729 GB children aged 11-17, and 1,191 GB parents and carers shows this summer will be particularly difficult for families because of the ongoing impact of the cost-of-living-crisis. Almost half of parents and carers (46%) surveyed said they will struggle to afford family holidays and days out. One in four (26%) can't fund activities like childcare and holiday clubs, and one in five (21%) won't be able to afford to time off work to spend with their children. # **DBS 3-year Renewal**

Thank you to everyone who continues to review the DBS checks for their parish in the move from the five year to three year renewal. A reminder that we have until **January 2024** to ensure that everyone has an in-date DBS certificate to conform with the three year renewal cycle.

When starting applications, please remember to use the drop-down menu to indicate the correct role for the application.

If someone decides to step down from a role and you have started their DBS application, please let us know so that we can withdraw it. In addition, if one of your Readers or Elders steps down from their role please inform us so that we can keep our records and our DBS checks up to date.

## **DBS Update Service**

We often receive queries relating to the update service. We rely on people telling us that they have signed up to the update service because it is a self-registered service. It isn't quite as straightforward as people anticipate - in order to complete a check the following process needs to be followed:

- 1. The certificate holder grants permission for a check to be made.
- 2. The following details are required: the number of the certificate registered, the person's date of birth, and the surname which is on the certificate.
- 3. A check can then be undertaken, but will only disclose whether there have been any changes since the certificate was issued.
- 4. The original certificate will still need to be viewed to check that the workforces recorded on it cover those required by the role.

For example: if the certificate registered on the update service only covers working with children and the current role requires a check for children and adults, it cannot be used. However, if the role involves only working with children and that was the original check, then we accept the certificate registered with the update service, and will not need to do a new application.

# Training

Over the last few weeks, there has been a disappointing uptake of our safeguarding courses. Please strongly encourage all those who need training to register for training. If you have a query about the level of training someone requires, the information can be found on the diocesan website <u>here</u> or through contacting one of the safeguarding team.

Remember that it is the individual's responsibility to update their training every three years and to keep their Safeguarding officer informed.

All training events for the remainder of the year are on Eventbrite. We continue to offer a range of times and days of the week. If someone is struggling to find an available course, please email <u>safeguardingtraining@cofesuffolk.org</u> as we often have last minute cancellations.
